In case of the proposed deletion of foot Note, it is done since there is no adhoc service possessed by the feeder (Librarians) for applying adhoc period while counting the period qualifying service promotion.

And, the selection of eligible feeder post for promotion to the vital post of Chief Librarian is considered to implement based on the merit cum seniority from those feeders with completion of the proposed qualifying period of service.
